**Canvassing and Certifying the 2022 Navajo Nation Primary Election  
Results for the Offices of Navajo Board of Education for all Agencies**

**WHEREAS:**

1. The Navajo Board of Election Supervisors are delegated by 11 N.N.C. §321 to supervise all Navajo tribal elections.
2. The 2022 Navajo Nation Primary Election was held on August 02, 2022 and the counting of the votes cast at 110 Chapter polling places have been completed by the Chief Poll Judges.
3. The canvassed results of the 2022 Navajo Nation Primary Election for the Offices Navajo Board of Education for all Agencies are attached and incorporated herein as Exhibit "A."
4. Pursuant to 11 N.N.C. §84(B) the Navajo Board of Election Supervisors shall canvass and certify the written statements of the election results from each polling place and total the results. And, pursuant to 11 N.N.C. §85, "not less than 10 days following each election, and at a regular meeting, the Board shall certify the names of candidates elected in such election."
5. The Board deems it is in the best interest of Navajo Nation voters and candidates that results of the 2022 Navajo Nation Primary Election for the elective offices referenced herein.

**NOW THEREFORE BE IT RESOLVED THAT:**

The Navajo Board of Election Supervisors of the Navajo Nation hereby canvasses and certifies election results for the 2022 Navajo Nation Primary Elections for the Offices of Navajo Board of Education for all Agencies.
