

RESOLUTION OF THE
NAVAJO BOARD OF ELECTION SUPERVISORS

**Canvassing and Certifying the 2022 Hand Counted Navajo Nation
Primary Election Results for the Position of Office of Navajo Nation President**

WHEREAS:

1. The Navajo Board of Election Supervisors are delegated by 11 N.N.C. § 321 to supervise all Navajo Nation elections.
2. Pursuant to 11 N.N.C. § 84(B) the Navajo Board of Election Supervisors must canvass the written statements of the election results from each polling place and total the results. And, pursuant to 11 N.N.C. §85, “not less than 10 days following each election, and at a regular meeting, the Board shall certify the names of candidates elected in such election.”
3. Pursuant to 11 N.N.C. § 41(C), “the primary candidates receiving the highest and next highest number of votes for the Office of the President, ... and other Elected Officers shall be candidates for those offices in the general election.”
4. The 2022 Navajo Nation Primary Election was held on August 2, 2022. Upon request, a recount for the position of the Office of the President was conducted August 29, 2022 to September 2, 2022. This recount was done by machine and hand recount. See attached Exhibit A (incorporated herein).
5. The recount referenced herein affected the proper registration of voters required under 11 N.N.C. §282(A), in particular, allowing applicants to officially register “beginning ten (10) days after” an election.
6. The Board deems it is in the best interest of Navajo Nation voters and candidates hand counted results of the 2022 Navajo Nation Primary Election for the elective offices be canvassed at this time.


NOW THEREFORE BE IT RESOLVED THAT:

1. The Navajo Board of Election Supervisors of the Navajo Nation hereby canvasses and certifies the hand counted results of the 2022 Navajo Nation Primary Election for the position of Office of Navajo Nation President, attached as **Exhibit “A.”**

2. The Navajo Nation Election Administration shall immediately complete all registration requests as required by law.
