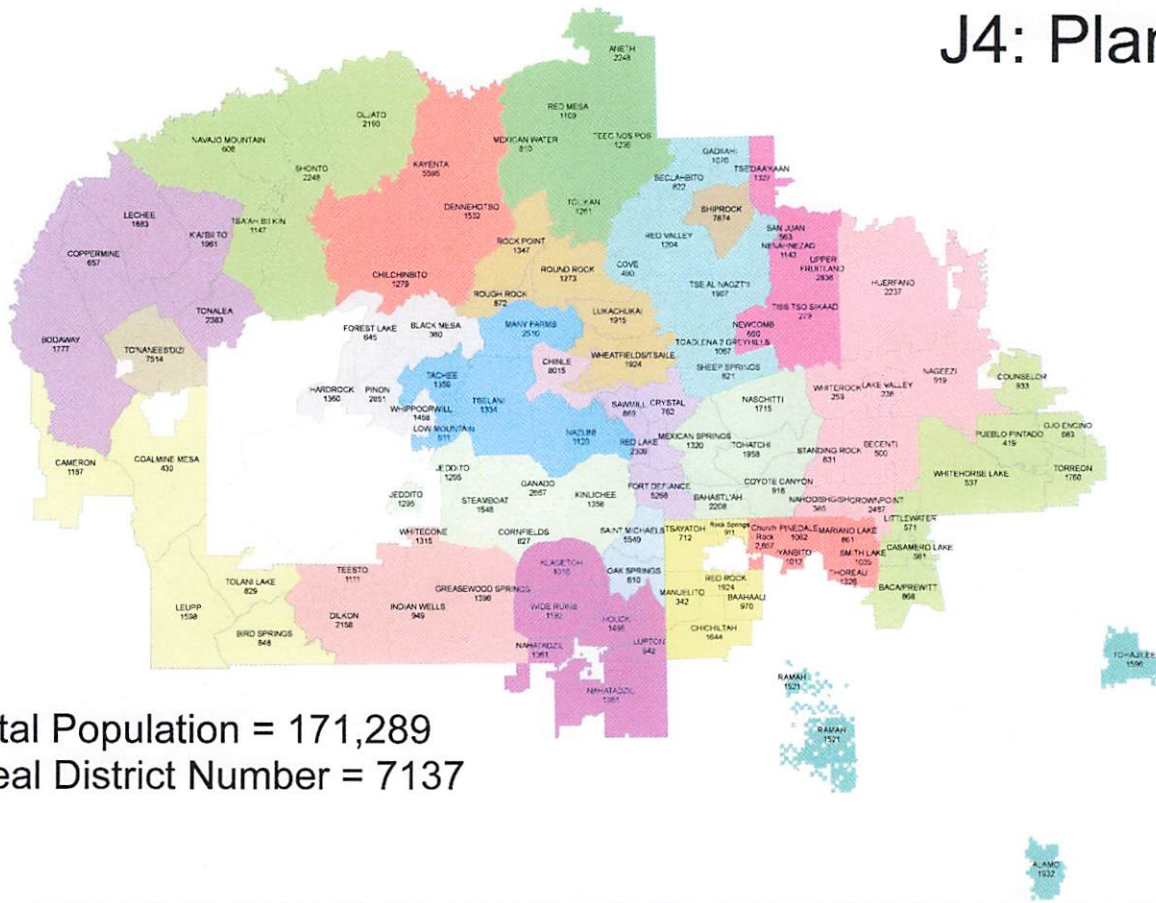

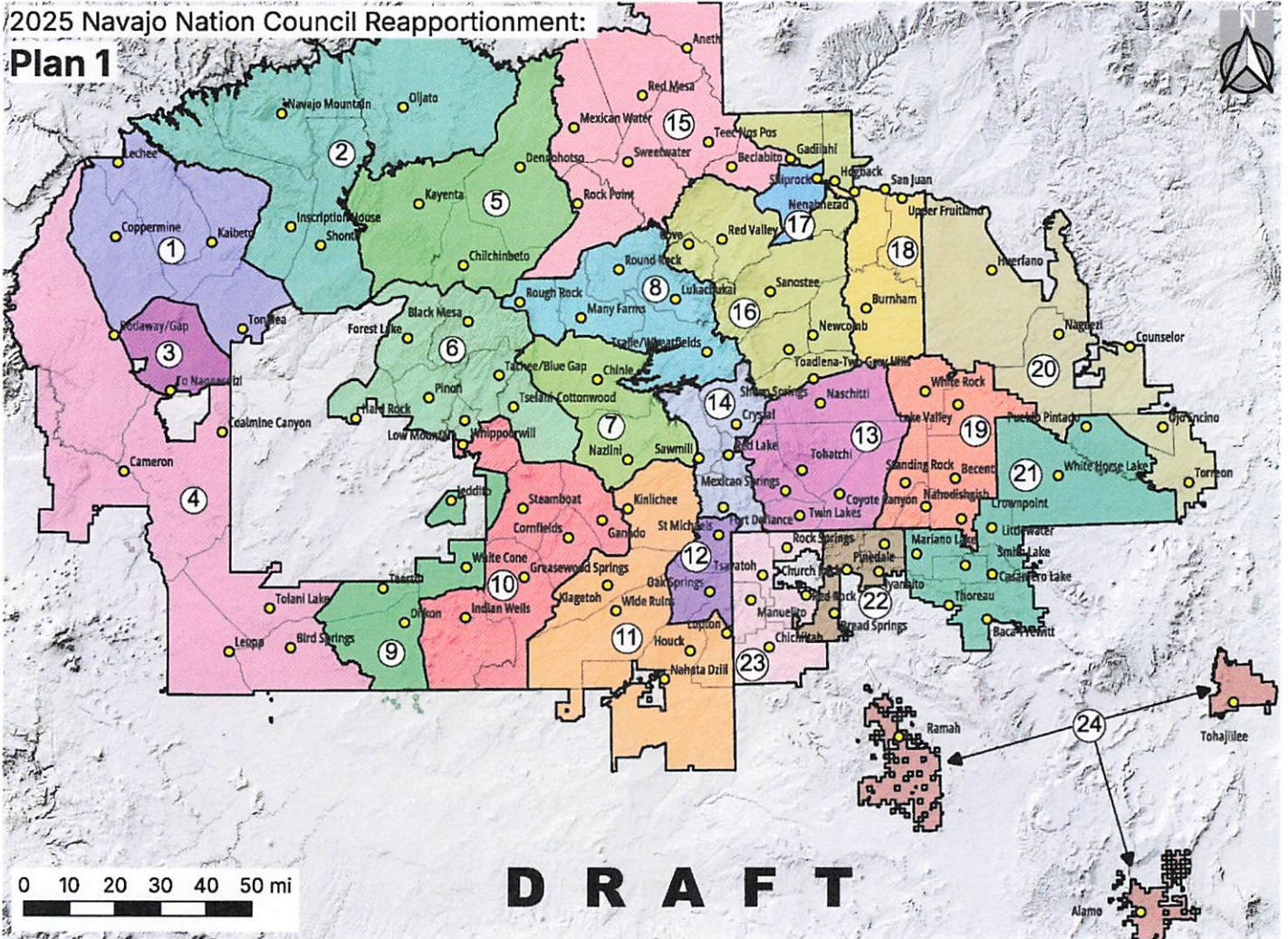

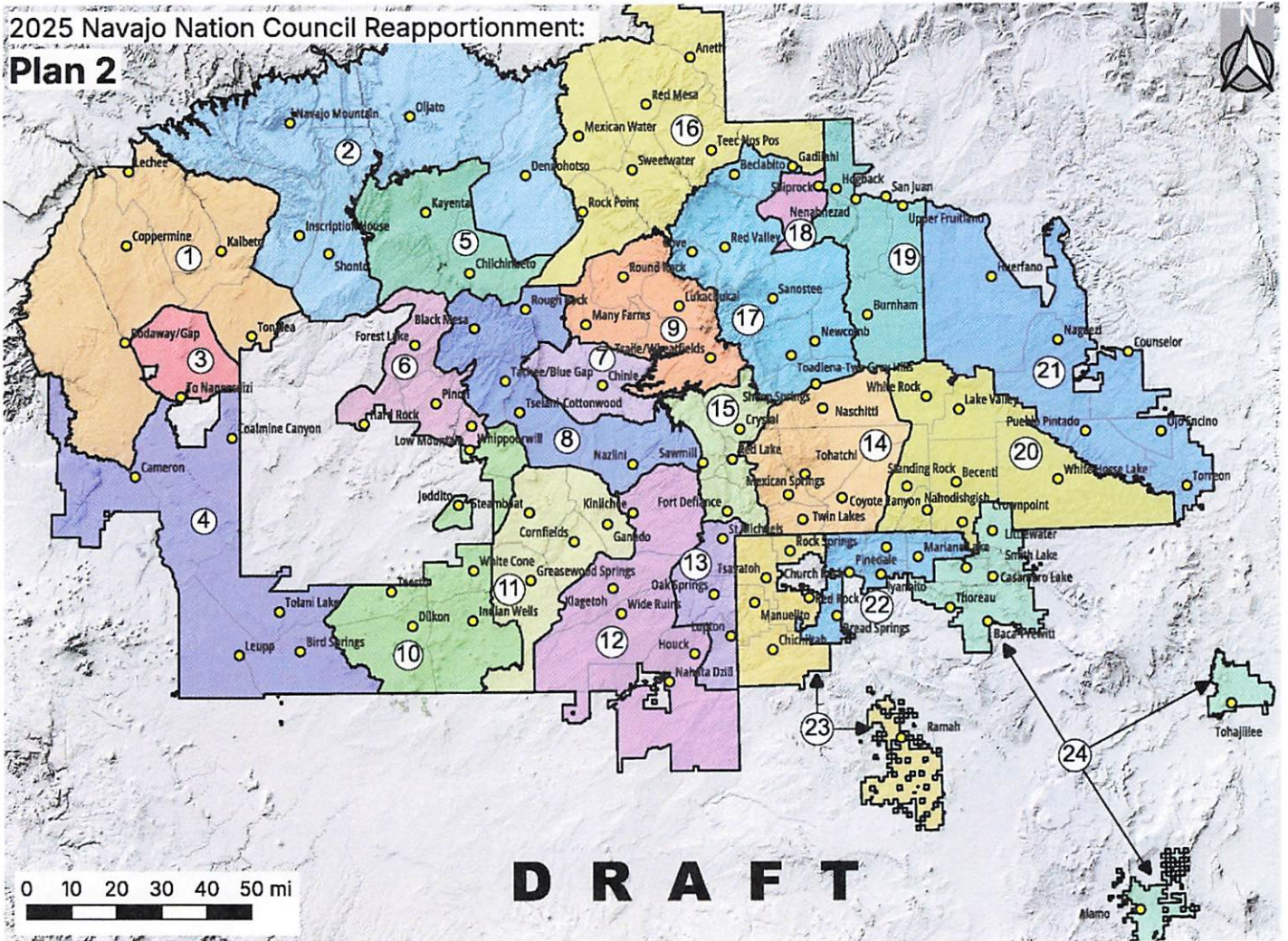

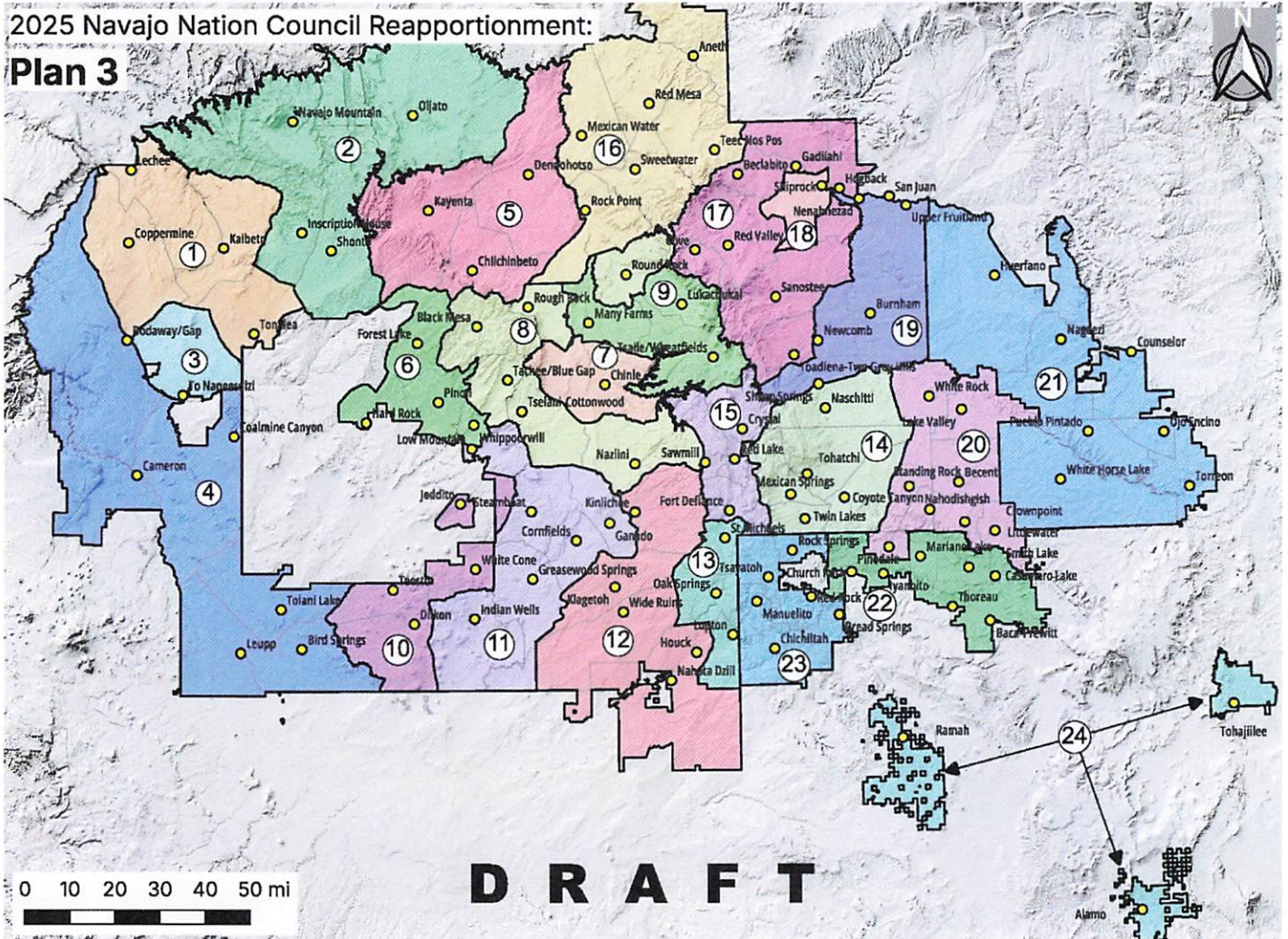
2025 Navajo Nation Council Reapportionment:

2025 Navajo Nation Council Reapportionment: Plan 2

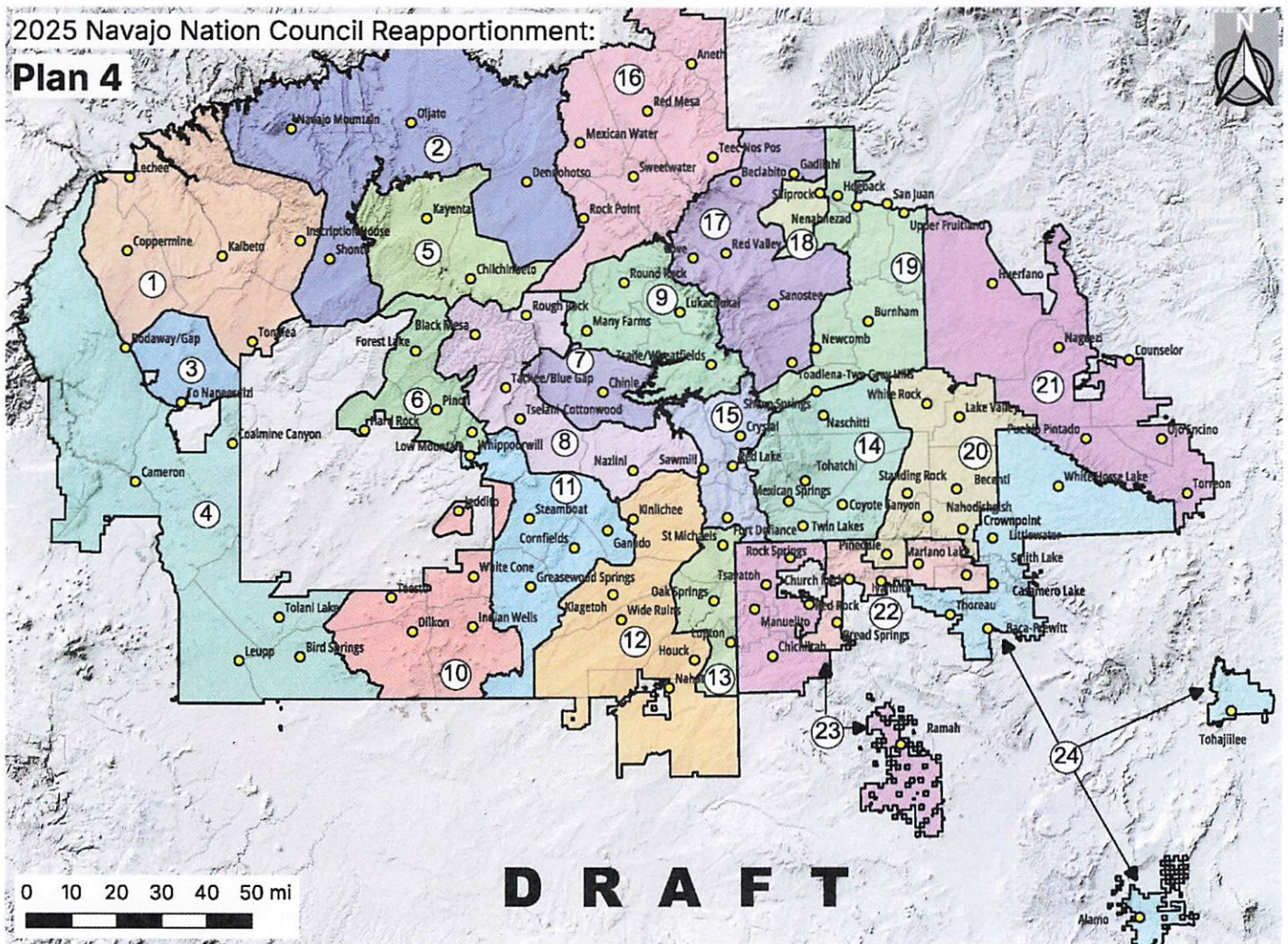
